All vendor applications will be reviewed. Submission of application does not guarantee your spot in the event. Upon approval all vendors will be allotted a food truck parking space or a 10x10 booth area to setup.

Event will happen rain or shine. Refunds will not be given for inclement weather unless cancelled by the Organizer.

### VENDOR REQUIREMENTS:

- Vendors will be responsible for providing and setting up their booth. Please bring your 10"x10" tent, tie downs to secure your tent, table, chairs, and lighting etc. There will be reserved spots along the sides of the park for food trucks.
- Provide a certificate of insurance with a minimum \$1 million per occurrence and \$2 million aggregate naming Little's Barbecue Co, LLC 10250 N Cedarburg Rd Mequon, WI 53092 and The Thiensville Business Association 250 Elm Street Thiensville, WI 53092 as additionally insured. - Be fully licensed in the state of Wisconsin to operate in Ozaukee County providing a copy of your mobile restaurant license or temporary restaurant license. Please email to [Little'sbbqco@gmail.com](mailto:Little'sbbqco@gmail.com)
- Meet all state health codes including having a Serve Safe Certified per present when vending. The health department may be making on site visits to ensure proper compliance.
- All food trucks and vendors that are deep frying must have a K type fire extinguisher with current service tags. All other vendors not frying must have a minimum of 1 2A:20BC fire extinguisher.
- Vendors will be responsible for collecting state sales tax and remitting as required.
- Electricity is available on a very limited basis and not guaranteed. Do not exceed 15 amps. You need to provide your own heavy-duty extension cord. One outlet per vendor.
- Loading and un-loading area is available for vendors Starting at 3:00 pm each event day. Please come see Jermaine Little with Little's Barbecue Company for vending space assignment. I can be reached at 414-640-9745
- **Reduced vendor fees are available for \$125 per event if you agree to co-market the events with your followers via Facebook, Instagram, and Twitter. In order to qualify for this reduced fee, you must like our Facebook page & post a minimum of 5 posts prior to each event tagging our Facebook page @FoodTrucksInThePark**
- Vendors may not sell alcoholic beverages. A beverage tent will be set up at village park to supply these items to the public.
